Dear Mr. Chairman:

This is in response to your request dated October 29, 1998, for a list of the names and case file identifiers for all offenders who were sentenced from 1993 to 1998 under the following statutes of Title 18, United States Code: § 4; § 1621; and § 1623.

Following conversations with Crime Subcommittee staff in which Department staff indicated that we do not normally provide information with personally identifying information, that request was narrowed to a breakdown, by gender, for each statute for inmates who are currently incarcerated and were sentenced between January 1993 and October 1998. That list is as follows:

Title 18, United States Code § 4: 117 males and 30 females.


Title 18, United States Code § 1621: 12 males and 4 females.

Title 18, United States Code § 1623: 78 males and 21 females.

This information does not indicate whether these individuals were also simultaneously convicted of additional offenses. Similarly, the information does not indicate whether the individuals had federal criminal convictions prior to the instant offenses. Finally, these numbers do not include persons who may have been convicted but received sentences that did not include incarceration nor those who have completed serving their sentences.
