Mr. DREIER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2738) to implement the United States-Chile Free Trade Agreement, and for consideration of the bill (H.R. 2739) to implement the United States-Singapore Free Trade Agreement.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order without intervention of any point of
3 order to consider in the House the bill (H.R. 2738) to
4 implement the United States-Chile Free Trade Agree-
5 ment. The bill shall be considered as read for amendment.

1 The bill shall be debatable for two hours, with one hour
2 and forty minutes equally divided and controlled by the
3 chairman and ranking minority member of the Committee
4 on Ways and Means and twenty minutes equally divided
5 and controlled by the chairman and ranking minority
6 member of the Committee on the Judiciary. Pursuant to
7 section 151(f)(2) of the Trade Act of 1974, the previous
8 question shall be considered as ordered on the bill to final
9 passage without intervening motion.

10 SEC. 2. Upon the adoption of this resolution it shall
11 be in order without intervention of any point of order to
12 consider in the House the bill (H.R. 2739) to implement
13 the United States-Singapore Free Trade Agreement. The
14 bill shall be considered as read for amendment. The bill
15 shall be debatable for two hours, with one hour and forty
16 minutes equally divided and controlled by the chairman
17 and ranking minority member of the Committee on Ways
18 and Means and twenty minutes equally divided and con-
19 trolled by the chairman and ranking minority member of
20 the Committee on the Judiciary. Pursuant to section
21 151(f)(2) of the Trade Act of 1974, the previous question
22 shall be considered as ordered on the bill to final passage
23 without intervening motion.

24 SEC. 3. During consideration of H.R. 2738 or H.R.
25 2739 pursuant to this resolution, notwithstanding the op-

- 1 eration of the previous question, the Chair may postpone
- 2 further consideration of the bill to a time designated by
- 3 the Speaker.
