Mr. FRIST (for himself, Mr. McCAIN, and Mrs. HUTCHISON) introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To reduce the number of deaths along the border between the United States and Mexico by improving the placement of rescue beacons, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Border Death Reduc-
5 tion Act of 2006”.

6 **SEC. 2. DEFINITION OF A RESCUE BEACON.**

7 In this Act, the term “rescue beacon” means a clearly
8 visible device with an internal power source that is placed
9 in an area likely to experience extreme weather, that con-

1 tains instructions for its use, and by means of lights, radio
2 signals, and other means, allows individuals to alert the
3 United States Customs and Border Protection of their
4 presence.

5 **SEC. 3. COLLECTION OF STATISTICS.**

6 (a) IN GENERAL.—Not later than 180 days after the
7 date of the enactment of this Act, the Commissioner of
8 Customs shall begin collecting data relevant to deaths oc-
9 ccurring at the border between the United States and Mex-
10 ico, divided by sector, and including—

- 11 (1) the causes of the deaths;
- 12 (2) the total number of deaths;
- 13 (3) the location of deaths; and
- 14 (4) demographic characteristics, including the
15 sex and approximate age of those deceased.

16 (b) DEVELOPMENT OF PROTOCOLS.—The Commis-
17 sioner of Customs shall develop consistent, formal, written
18 protocols for the collection of data described in subsection
19 (a).

20 **SEC. 4. ANNUAL REPORT ON BORDER DEATHS.**

21 Not later than 1 year after the date of the enactment
22 of this Act, and annually thereafter, the Commissioner of
23 Customs shall submit to the Secretary of Homeland Secu-
24 rity a report that contains—

1 (1) an analysis of trends with respect to the
2 statistics collected under section (3)(a)(1) during the
3 preceding year;

4 (2) an evaluation, using multivariate statistical
5 approaches, of the Border Safety Initiative, includ-
6 ing any rescue beacons deployed, and any successor
7 program designed to reduce deaths along the border
8 described in section 3(a); and

9 (3) recommendations of particular actions to re-
10 duce the deaths described in section 3(a).

11 **SEC. 5. REPORT ON BEACON PLACEMENT.**

12 (a) **REPORT REQUIRED.**—Not later than 6 months
13 after the date of the enactment of this Act, the Commis-
14 sioner of Customs shall submit to the Secretary of Home-
15 land Security a report on enhancing the deployment of res-
16 cue beacons.

17 (b) **FOCUS OF REPORT.**—Such report shall contain
18 particular emphasis on enhancing the deployment of res-
19 cue beacons in the Tucson Sector.

20 (c) **CONTENTS OF REPORT.**—The report required by
21 subsection (a) shall include—

22 (1) an assessment of the efficacy of the deploy-
23 ment of rescue beacons in light of the statistics
24 gathered under section 3, including analysis of the

1 locations of deaths recorded and areas frequented by
2 illegal migrants; and

3 (2) recommendations on where additional res-
4 cue beacons should be placed to reduce the number
5 of deaths in the area described by section 3 and sec-
6 tion 5(b).

7 (d) AUTHORIZATION OF APPROPRIATIONS.—There
8 are authorized to be appropriated \$500,000 to carry out
9 the provisions of this section.

10 **SEC. 6. DEPLOYMENT OF ENHANCED BEACON NETWORK.**

11 (a) DEPLOYMENT OF RESCUE BEACONS.—Not later
12 than 1 year after the date of the enactment of this Act,
13 the Commissioner of Customs shall deploy additional res-
14 cue beacons in all areas recommended in the report re-
15 quired by section 5.

16 (b) GUIDELINES FOR PLACEMENT OF RESCUE BEA-
17 CONS.—Not later than 1 year after the date of the enact-
18 ment of this Act, the Commissioner of Customs shall issue
19 to all sector chiefs formal, written guidelines for the ongo-
20 ing placement and removal of rescue beacons and the ap-
21 propriate response to the activation of such beacons.

22 (c) AUTHORIZATION OF APPROPRIATIONS.—There
23 are authorized to be appropriated \$1,500,000 to carry out
24 the provisions of this section.

1 **SEC. 7. PROHIBITION ON ABANDONMENT OF ALIENS IN A**
2 **BORDER ZONE.**

3 (a) IN GENERAL.—Any person who commits an act
4 described in section 274(a)(1)(A) of the Immigration and
5 Nationality Act (8 U.S.C. 1324(a)(1)(A)) and abandons
6 an alien with respect to that act in a place not within sight
7 of a paved road or rescue beacon, shall be considered to
8 have placed in jeopardy the life of a person as described
9 in section 274(a)(1)(B)(iii) of such Act (8 U.S.C.
10 1324(a)(1)(B)(iii)).

11 (b) CONSTRUCTION.—Nothing in this section shall be
12 construed to prohibit any person from being held in viola-
13 tion of section 274(a)(1)(B)(iii) of such Act (8 U.S.C.
14 1324 (B)(iii)).
