9	(a) In General.—Chapter 22 of title 44, United				
10	States Code, is amended by adding at the end the following

- 8 public the record covered by the notice, except any record
- 9 (or reasonably segregable part of a record) with respect
- 10 to which the Archivist receives from a former President
- 11 or the incumbent President notification of a claim of con-
- 12 stitutionally based privilege against disclosure under sub-
- 13 section (b).
- 14 "(B) A former President or the incumbent President
- 15 may extend the period under subparagraph (A) once for
- 16 not more than 20 additional days (excepting Saturdays,
- 17 Sundays, and legal public holidays) by filing with the Ar-
- 18 chivist a statement that such an extension is necessary
- 19 to allow an adequate review of the record.
- 20 "(C) Notwithstanding subparagraphs (A) and (B), if
- 21 the period under subparagraph (A), or any extension of
- 22 that period under subparagraph (B), would otherwise ex-
- 23 pire after January 19 and before July 20 of the year in
- 24 which the incumbent President first takes office, then such

- 1 period or extension, respectively, shall expire on July 20
- 2 of that year.
- 3 "(b)(1) For purposes of this section, any claim of
- 4 constitutionally based privilege against disclosure must be
- 5 asserted personally by a former President or the incum-
- 6 bent President, as applicable.
- 7 "(2) A former President or the incumbent President
- 8 shall notify the Archivist, the Committee on Oversight and
- 9 Government Reform of the House of Representatives, and
- 10 the Committee on Homeland Security and Governmental
- 11 Affairs of the Senate of a privilege claim under paragraph
- 12 (1) on the same day that the claim is asserted under para-
- 13 graph (1).
- 14 "(c)(1) The Archivist shall not make publicly avail-
- 15 able a Presidential record that is subject to a privilege
- 16 claim asserted by a former President until the expiration
- 17 of the 20-day period (excluding Saturdays, Sundays, and
- 18 legal public holidays) beginning on the date the Archivist
- 19 is notified of the claim.
- 20 "(2) Upon the expiration of such period the Archivist
- 21 shall make the record publicly available unless otherwise
- 22 directed by a court order in an action initiated by the
- 23 former President under section 2204(e).

- 1 "(d)(1) The Archivist shall not make publicly avail-
- 2 able a Presidential record that is subject to a privilege
- 3 claim asserted by the incumbent President unless—
- 4 "(A) the incumbent President withdraws the
- 5 privilege claim; or
- 6 "(B) the Archivist is otherwise directed by a
- 7 final court order that is not subject to appeal.
- 8 "(2) This subsection shall not apply with respect to
- 9 any Presidential record required to be made available
- 10 under section 2205(2)(A) or (C).
- 11 "(e) The Archivist shall adjust any otherwise applica-
- 12 ble time period under this section as necessary to comply
- 13 with the return date of any congressional subpoena, judi-
- 14 cial subpoena, or judicial process.".
- 15 (b) Restrictions.—Section 2204 of title 44, United
- 16 States Code (relating to restrictions on access to presi-
- 17 dential records) is amended by adding at the end the fol-
- 18 lowing new subsection:
- 19 "(f) The Archivist shall not make available any origi-
- 20 nal presidential records to any individual claiming access
- 21 to any presidential record as a designated representative
- 22 under section 2205(3) if that individual has been convicted
- 23 of a crime relating to the review, retention, removal, or de-
- 24 struction of records of the Archives.".

- 1 (b) (c) Conforming Amendments.—(1) Section
- 2 2204(d) of title 44, United States Code, is amended by
- 3 inserting ", except section 2208," after "chapter".
- 4 (2) Section 2207 of title 44, United States Code, is
- 5 amended in the second sentence by inserting ", except sec-
- 6 tion 2208," after "chapter".
