A BILL

To establish the National Landscape Conservation System,
and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “National Landscape*
5 *Conservation System Act”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *SECRETARY.*—*The term “Secretary” means*
9 *the Secretary of the Interior.*

10 (2) *SYSTEM.*—*The term “system” means the Na-*
11 *tional Landscape Conservation System established by*
12 *section 3(a).*

13 **SEC. 3. ESTABLISHMENT OF THE NATIONAL LANDSCAPE**
14 **CONSERVATION SYSTEM.**

15 (a) *ESTABLISHMENT.*—*In order to conserve, protect,*
16 *and restore nationally significant landscapes that have out-*
17 *standing cultural, ecological, and scientific values for the*
18 *benefit of current and future generations, there is estab-*

1 *lished in the Bureau of Land Management the National*
2 *Landscape Conservation System.*

3 (b) *COMPONENTS.—The system shall include each of*
4 *the following areas administered by the Bureau of Land*
5 *Management:*

6 (1) *Each area that is designated as—*

7 (A) *a national monument;*

8 (B) *a national conservation area;*

9 (C) *a wilderness study area;*

10 (D) *a National Scenic Trail or National*
11 *Historic Trail designated as a component of the*
12 *National Trails System;*

13 (E) *a component of the National Wild and*
14 *Scenic Rivers System; or*

15 (F) *a component of the National Wilderness*
16 *Preservation System.*

17 (2) *Any area designated by Congress to be ad-*
18 *ministered for conservation purposes, including—*

19 (A) *the Steens Mountain Cooperative Man-*
20 *agement and Protection Area, as designated*
21 *under section 101(a) of the Steens Mountain Co-*
22 *operative Management and Protection Act of*
23 *2000 (16 U.S.C. 460nnn–11(a));*

24 (B) *the Headwaters Forest Reserve;*

1 (C) the Yaquina Head Outstanding Natural
2 Area; and

3 (D) any additional area designated by Con-
4 gress for inclusion in the system.

5 (c) *MANAGEMENT.*—*The Secretary shall manage the*
6 *system—*

7 (1) *in accordance with each applicable law (in-*
8 *cluding regulations) relating to each component of the*
9 *system included under subsection (b); and*

10 (2) *in a manner that protects the values for*
11 *which the components of the system were designated.*

12 **SEC. 4. STATUTORY CONSTRUCTION.**

13 *Nothing in this Act shall be construed to enhance, di-*
14 *minish, or modify any law or proclamation (or regulations*
15 *related to such law or proclamation) under which the com-*
16 *ponents of the system identified in section 3(b) were estab-*
17 *lished, or are managed, including, but not limited to, the*
18 *Alaska National Interest Land Conservation Act (43 U.S.C.*
19 *1601 et seq.), the Wilderness Act (16 U.S.C. 1131 et seq.),*
20 *the Wild and Scenic Rivers Act (16 U.S.C. 1271 et seq.),*
21 *the National Trails System Act (16 U.S.C. 1241 et seq.),*
22 *and the Federal Land Policy and Management Act of 1976*
23 *(43 U.S.C. 1701 et seq.).*
