## A BILL

To amend the Fair Labor Standards Act of 1938 to provide for an increase in the Federal minimum wage.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fair Minimum Wage
- 5 Act of 2007".
- 6 SEC. 2. MINIMUM WAGE.
- 7 (a) IN GENERAL.—Section 6(a)(1) of the Fair Labor
