"(4) In this subsection, the term 'information' includes any information of a personal or professional nature, including the name, cover status, clearance status,
and areas of expertise of a person.".

19 (1) by inserting "or has served" after "is serv-20 ing"; and

(2) by striking "or has within the last five yearsserved outside the United States".
