A BILL

To amend title 18, United States Code, with respect to cyberbullying.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Megan Meier

5 Cyberbullying Prevention Act".

6 SEC. 2. FINDINGS.

7 Congress finds the following:

8 (1) Four out of five of United States children
9 aged 2 to 17 live in a home where either they or
10 their parents access the Internet.

(2) Youth who create Internet content and use
 social networking sites are more likely to be targets
 of cyberbullying.

4 (3) Electronic communications provide anonym5 ity to the perpetrator and the potential for wide6 spread public distribution, potentially making them
7 severely dangerous and cruel to youth.

8 (4) Online victimizations are associated with
9 emotional distress and other psychological problems,
10 including depression.

(5) Cyberbullying can cause psychological harm,
including depression; negatively impact academic
performance, safety, and the well-being of children
in school; force children to change schools; and in
some cases lead to extreme violent behavior, including murder and suicide.

17 (6) Sixty percent of mental health professionals
18 who responded to the Survey of Internet Mental
19 Health Issues report having treated at least one pa20 tient with a problematic Internet experience in the
21 previous five years; 54 percent of these clients were
22 18 years of age or younger.

1 SEC. 3. CYBERBULLYING.

2 (a) IN GENERAL.—Chapter 41 of title 18, United
3 States Code, is amended by adding at the end the fol4 lowing:

5 "§ 881. Cyberbullying

6 "(a) Whoever transmits in interstate or foreign com-7 merce any communication, with the intent to coerce, in-8 timidate, harass, or cause substantial emotional distress 9 to a person, using electronic means to support severe, re-10 peated, and hostile behavior, shall be fined under this title 11 or imprisoned not more than two years, or both.

12 "(b) As used in this section—

13 "(1) the term 'communication' means the elec-14 tronic transmission, between or among points speci-15 fied by the user, of information of the user's choos-16 ing, without change in the form or content of the in-17 formation as sent and received; and

"(2) the term 'electronic means' means any
equipment dependent on electrical power to access
an information service, including email, instant messaging, blogs, websites, telephones, and text messages.".
