To amend the Marine Mammal Protection Act of 1972 to strengthen polar bear conservation efforts, and for other purposes.

Mr. Kerry (for himself and Ms. Snowe) introduced the following bill; which was read twice and referred to the Committee on Commerce, Science, and Transportation

## A BILL

To amend the Marine Mammal Protection Act of 1972 to strengthen polar bear conservation efforts, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Polar Bear Protection
- 5 Act of 2007".
- 6 SEC. 2. FINDINGS AND PURPOSES.
- 7 (a) FINDINGS.—Congress finds that—
- 8 (1) section 101 of the Marine Mammal Protec-
- 9 tion Act of 1972 (16 U.S.C. 1371) establishes a

1	moratorium relating to the importation of marine
2	mammals and marine mammal products, including
3	the importation of all sport-hunted marine mammal
4	trophies;
5	(2) in 1994, that Act was amended to create an
6	exemption from the moratorium that allows the im-
7	portation of sport-hunted polar bear trophies from
8	Canada;
9	(3) this exemption has increased Canadian
10	polar bear mortalities from United States sport
11	hunters;
12	(4) polar bears—
13	(A) have low reproductive rates;
14	(B) have long lives;
15	(C) rely on high adult survival rates to
16	maintain population numbers; and
17	(D) are under stress from climate change
18	and habitat degradation;
19	(5) in July 2005, the World Conservation
20	Union Polar Bear Specialist Group released a quad-
21	rennial report, in which the Group—
22	(A) reviewed the status of polar bears; and
23	(B) concluded that the species should be
24	upgraded from "a species of least concern" to
25	"vulnerable" based on the "likelihood of an

overall decline in the size of the total population of more than 30 percent within the next 35 to 50 years"; and

(6) based on threats posed to polar bears, on December 27, 2006, the Department of the Interior proposed that polar bears be listed under the Endangered Species Act of 1973 (16 U.S.C. 1531 et seq.) as a threatened species.

### (b) Purposes.—The purposes of this Act are—

- (1) to ensure that citizens of the United States do not contribute to polar bear mortalities in Canada by removing the exemption in the Marine Mammal Protection Act of 1972 (16 U.S.C. 1361 et seq.) that allows for the Secretary of the Interior to issue permits to United States trophy hunters for the importation of polar bear trophies from Canada;
- (2) to heed the warnings of the Department of the Interior and the World Conservation Union Polar Bear Specialist Group that polar bears are at risk and could become endangered by prohibiting the importation of polar bear trophies from Canada; and
- (3) to further the goals of the International Agreement on the Conservation of Polar Bears, done at Oslo, November 15, 1973 (27 UST 3918), to

1	which all 5 countries with polar bears within the
2	borders of the countries are a party.
3	SEC. 3. PROHIBITION OF THE IMPORTATION OF POLAR
4	BEARS AND POLAR BEAR PARTS.
5	The Marine Mammal Protection Act of 1972 (16
6	U.S.C. 1361 et seq.) is amended—
7	(1) in section $101(a)(1)$ (16 U.S.C.
8	1371(a)(1))—
9	(A) in the first sentence, by striking ", or
10	for importation of polar bear parts (other than
11	internal organs) taken in sport hunts in Can-
12	ada" and inserting ", except that no permit
13	may be issued under this Act for the importa-
14	tion of polar bear parts taken in a sport hunt";
15	(B) in the second sentence, by striking ",
16	except permits issued under section 104(c)(5),";
17	and
18	(C) in the third sentence, by striking ",
19	other than importation under section
20	104(e)(5),"; and
21	(2) in section 104 (16 U.S.C. 1374)—
22	(A) in subsection (c)—
23	(i) in paragraph (2)(E), by striking
24	"paragraph (10)" and inserting "para-
25	eraph (9)":

1	(ii) in paragraph (8)(B)(ii), by strik-
2	ing "paragraph (10)" and inserting "para-
3	graph (9)";
4	(iii) by striking paragraph (5); and
5	(iv) by redesignating paragraphs (6)
6	through (10) as paragraphs (5) through
7	(9), respectively; and
8	(B) in subsection (e)(1)—
9	(i) in subparagraph (A), by striking
10	the comma and inserting "; or";
11	(ii) in subparagraph (B), by striking
12	", or" and inserting a period; and
13	(iii) by striking subparagraph (C).
