## A BILL

To redesignate the Office for Vocational and Adult Education as the Office of Career, Technical, and Adult Education.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. REDESIGNATION OF THE OFFICE OF VOCA-**  
4       **TIONAL AND ADULT EDUCATION.**

5       (a) REDESIGNATION.—Section 206 of the Depart-  
6       ment of Education Organization Act (20 U.S.C. 3416) is  
7       amended—

8               (1) in the section heading, by striking “OFFICE  
9       OF VOCATIONAL AND ADULT EDUCATION” and in-

1       serting “OFFICE OF CAREER, TECHNICAL, AND  
2       ADULT EDUCATION”;

3               (2) in the first sentence—

4                       (A) by striking “Office of Vocational and  
5                       Adult Education” and inserting “Office of Ca-  
6                       reer, Technical, and Adult Education”; and

7                       (B) by striking “Assistant Secretary for  
8                       Vocational and Adult Education” and inserting  
9                       “Assistant Secretary for Career, Technical, and  
10                      Adult Education”; and

11               (3) in the second sentence, by striking “voca-  
12               tional and adult education” each place the term ap-  
13               pears and inserting “career, technical, and adult  
14               education”.

15       (b) CONFORMING AMENDMENTS.—

16               (1) DEPARTMENT OF EDUCATION ORGANIZA-  
17               TION ACT.—The Department of Education Organi-  
18               zation Act (as amended in subsection (a)) (20  
19               U.S.C. 3401 et seq.) is further amended—

20                       (A) in section 202—

21                               (i) in subsection (b)(1)(C), by striking  
22                               “Assistant Secretary for Vocational and  
23                               Adult Education” and inserting “Assistant  
24                               Secretary for Career, Technical, and Adult  
25                               Education”; and

1                   (ii) in subsection (h), by striking “As-  
2                   sistant Secretary for Vocational and Adult  
3                   Education” each place the term appears  
4                   and inserting “Assistant Secretary for Ca-  
5                   reer, Technical, and Adult Education”;  
6                   and

7                   (B) in the table of contents in section 1,  
8                   by striking the item relating to section 206 and  
9                   inserting the following:

“Sec. 206. Office of Career, Technical, and Adult Education.”.

10                   (2) CARL D. PERKINS CAREER AND TECHNICAL  
11                   EDUCATION ACT OF 2006.—Section 114(b)(1) of the  
12                   Carl D. Perkins Career and Technical Education  
13                   Act of 2006 (20 U.S.C. 2324(b)(1)) is amended by  
14                   striking “Office of Vocational and Adult Education”  
15                   and inserting “Office of Career, Technical, and  
16                   Adult Education”.
