# **A BILL**

To amend the Help America Vote Act of 2002 to allow all eligible voters to vote by mail in Federal elections.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Universal Right to Vote*  
5 *by Mail Act of 2009”.*

6 **SEC. 2. FINDINGS.**

7 *Congress finds the following:*

8 *(1) An inequity of voting rights exists in the*  
9 *United States because voters in some States have the*  
10 *universal right to vote by mail while voters in other*  
11 *States do not.*

12 *(2) Many voters often have work, family, or*  
13 *other commitments that make getting to polls on the*  
14 *date of an election difficult or impossible. Under cur-*  
15 *rent State laws, many of these voters are not per-*  
16 *mitted to vote by mail.*

17 *(3) 28 States currently allow universal absentee*  
18 *voting (also known as “no-excuse” absentee voting),*  
19 *which permits any voter to request a mail-in ballot*  
20 *without providing a reason for the request, and no*  
21 *State which has implemented no-excuse absentee vot-*  
22 *ing has switched back.*

23 *(4) Voting by mail gives voters more time to con-*  
24 *sider their choices, which is especially important as*  
25 *many ballots contain greater numbers of questions*

1       *about complex issues than in the past due to the ex-*  
2       *panded use of the initiative and referendum process*  
3       *in many States.*

4               (5) *Allowing all voters the option to vote by mail*  
5       *can lead to increased voter participation.*

6               (6) *Allowing all voters the option to vote by mail*  
7       *can reduce waiting times for those voters who choose*  
8       *to vote at the polls.*

9               (7) *Voting by mail is preferable to many voters*  
10       *as an alternative to going to the polls. Voting by mail*  
11       *has become increasingly popular with voters who*  
12       *want to be certain that they are able to vote no mat-*  
13       *ter what comes up on Election Day.*

14              (8) *No evidence exists suggesting the potential for*  
15       *fraud in absentee balloting is greater than the poten-*  
16       *tial for fraud by any other method of voting.*

17              (9) *Many of the reasons which voters in many*  
18       *States are required to provide in order to vote by*  
19       *mail require the revelation of personal information*  
20       *about health, travel plans, or religious activities,*  
21       *which violate voters' privacy while doing nothing to*  
22       *prevent voter fraud.*

23              (10) *State laws which require voters to obtain a*  
24       *notary signature to vote by mail only add cost and*  
25       *inconvenience to voters without increasing security.*

1 **SEC. 3. PROMOTING ABILITY OF VOTERS TO VOTE BY MAIL**  
2 **IN FEDERAL ELECTIONS.**

3 (a) *IN GENERAL.*—Subtitle A of title III of the Help  
4 America Vote Act of 2002 (42 U.S.C. 15481 et seq.) is  
5 amended by inserting after section 303 the following new  
6 section:

7 **“SEC. 303A. PROMOTING ABILITY OF VOTERS TO VOTE BY**  
8 **MAIL.**

9 “(a) *IN GENERAL.*—If an individual in a State is eli-  
10 gible to cast a vote in an election for Federal office, the  
11 State may not impose any additional conditions or require-  
12 ments on the eligibility of the individual to cast the vote  
13 in such election by mail, except as required under sub-  
14 section (b) and except to the extent that the State imposes  
15 a deadline for requesting the ballot and related voting mate-  
16 rials from the appropriate State or local election official  
17 and for returning the ballot to the appropriate State or  
18 local election official.

19 “(b) *REQUIRING SIGNATURE VERIFICATION.*—

20 “(1) *RECORD OF SIGNATURE REQUIRED FOR*  
21 *PROVISION OF BALLOT.*—A State may not provide an  
22 absentee ballot to an individual for an election for  
23 Federal office unless the individual’s signature is in-  
24 cluded on the official list of registered voters in the  
25 State or some other official record of the State con-  
26 nected to such list.

1           “(2) *VERIFICATION REQUIRED FOR ACCEPTANCE*  
2           *AND PROCESSING OF SUBMITTED BALLOT.*—A State  
3           *may not accept and process an absentee ballot sub-*  
4           *mitted by any individual for an election for Federal*  
5           *office unless the State verifies the identification of the*  
6           *individual by comparing the individual’s signature*  
7           *on the absentee ballot with the individual’s signature*  
8           *on the official list or other official record referred to*  
9           *in paragraph (1), in accordance with such procedures*  
10          *as the State may adopt.*

11          “(c) *RULE OF CONSTRUCTION.*—Nothing in this sec-  
12          *tion shall be construed to affect the authority of States to*  
13          *conduct elections for Federal office through the use of polling*  
14          *places at which individuals cast ballots on the date of the*  
15          *election.*

16          “(d) *EFFECTIVE DATE.*—A State shall be required to  
17          *comply with the requirements of this section with respect*  
18          *to elections for Federal office held in years beginning with*  
19          *2012.”.*

20          “(b) *CONFORMING AMENDMENT RELATING TO EN-*  
21          *FORCEMENT.*—Section 401 of such Act (42 U.S.C. 15511)  
22          *is amended by striking “and 303” and inserting “303, and*  
23          *303A”.*

1           (c) *CLERICAL AMENDMENT.*—*The table of contents for*  
2 *such Act is amended by inserting after the item relating*  
3 *to section 303 the following new item:*

*“Sec. 303A. Promoting ability of voters to vote by mail.”.*
