# **A BILL**

To provide for identifying and eliminating redundant reporting requirements and developing meaningful performance metrics for homeland security preparedness grants, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Redundancy Elimination and Enhanced Performance for Preparedness Grants Act”.

7 **SEC. 2. IDENTIFICATION OF REPORTING REDUNDANCIES**  
8                   **AND DEVELOPMENT OF PERFORMANCE**  
9                   **METRICS FOR HOMELAND SECURITY PRE-**  
10                   **PAREDNESS GRANT PROGRAMS.**

11       (a) IN GENERAL.—Title XX of the Homeland Security Act of 2002 (6 U.S.C. 601 et seq.) is amended by adding at the end the following new section:

14 **“SEC. 2023. IDENTIFICATION OF REPORTING**  
15                   **REDUNDANCIES AND DEVELOPMENT OF PER-**  
16                   **FORMANCE METRICS.**

17       “(a) IN GENERAL.—The Administrator shall, for  
18 grants under sections 2003 and 2004 and any other  
19 grants specified by the Administrator, submit a report to  
20 the congressional homeland security committees by not  
21 later than 120 days after the date of the enactment of  
22 the Redundancy Elimination and Enhanced Performance  
23 for Preparedness Grants Act, and by October 1st every  
24 2 years thereafter, that—

1           “(1) identifies redundant rules, regulations, and  
2 requirements for reporting by recipients of such  
3 grants, and includes a plan for eliminating such  
4 identified redundancies and requirements;

5           “(2) includes a plan for developing and improv-  
6 ing the performance metrics required under section  
7 2022(a)(4) for such grants; and

8           “(3) includes an assessment of each program  
9 under which such grants are awarded.

10          “(b) PLAN REQUIREMENTS.—Each plan under sub-  
11 section (a)—

12           “(1) shall be developed in coordination with  
13 State, local, tribal, and territorial governments; and

14           “(2) shall include a proposed timeline for ac-  
15 tions to implement the plan.

16          “(c) PROGRAM ASSESSMENT REQUIREMENTS.—Each  
17 program assessment under subsection (a)(3) shall in-  
18 clude—

19           “(1) a brief summary of the program purposes,  
20 objectives, and performance goals, and of the key  
21 findings of the assessment;

22           “(2) an assessment of the quality of the pro-  
23 gram’s performance metrics, and the extent to which  
24 necessary performance data are collected;

1           “(3) a summary of how the program’s strengths  
2           and weaknesses are impeding or contributing to its  
3           failures or successes, including reasons for any sub-  
4           stantial variation from the targeted level of perform-  
5           ance of the program;

6           “(4) a description of the extent to which any  
7           trends, developments, or emerging conditions affect  
8           the need to change the mission of the program or  
9           the way that the program is being carried out;

10          “(5) an identification of the best practices used  
11          in the program for allocating resources in an effi-  
12          cient and effective manner that resulted in positive  
13          outcomes and the key reasons why such practices re-  
14          sulted in positive outcomes;

15          “(6) recommendations for program modifica-  
16          tions to improve the results that the program  
17          achieves;

18          “(7) a summary of key results of the program  
19          assessment that support maximizing the amount of  
20          funds appropriated for the program; and

21          “(8) an assessment of the quality of customer  
22          service offered to recipients of funds under the pro-  
23          gram and a strategy for improving such service.

24          “(d) CONGRESSIONAL HOMELAND SECURITY COM-  
25          MITTEES DEFINED.—In this section the term ‘congres-

1 sional homeland security committees’ means the Com-  
2 mittee on Homeland Security of the House of Representa-  
3 tives and the Committee on Homeland Security and Gov-  
4 ernmental Affairs of the Senate.”.

5 (b) CLERICAL AMENDMENT.—The table of contents  
6 in section 1(b) of such Act is amended by adding at the  
7 end of the items relating to title XX the following new  
8 item:

“Sec. 2023. Identification of reporting redundancies and development of per-  
formance metrics.”.
