 preserve records and establish electronically searchable
 databases consisting of local records of servitude, emanci pation, and post-Civil War reconstruction.

7 "(b) MAINTENANCE.—Any database established
8 using a grant under this section shall be maintained by
9 appropriate agencies or institutions designated by the Ar10 chivist of the United States.".
