3	"(D) In the case of an individual enrolled
4	in a program of education that is pursued ex-
5	clusively by correspondence, an amount equal to
6	the lesser of—
7	"(i) the established charges for the

9	"(ii) 55 percent of the amount of the
10	average of the established charges at all in-
11	stitutions of higher learning in the United
12	States for a program of education leading
13	to a baccalaureate degree as determined by
14	the National Center for Education Statis-

16	the most recent academic year.
