A BILL

To provide for prostate cancer imaging research and education.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Prostate Research, Im-
- 5 aging, and Men's Education Act" or the "PRIME Act".
- 6 SEC. 2. RESEARCH AND DEVELOPMENT OF PROSTATE CAN-
- 7 CER IMAGING TECHNOLOGIES.
- 8 (a) Expansion of Research.—The Secretary of
- 9 Health and Human Services (referred to in this Act as
- 10 the "Secretary"), acting through the Director of the Na-
- 11 tional Institutes of Health and in consultation with the

- 1 Secretary of Defense, shall carry out a program to expand
- 2 and intensify research to develop innovative advanced im-
- 3 aging technologies for prostate cancer detection, diagnosis,
- 4 and treatment comparable to state-of-the-art mammog-
- 5 raphy technologies.
- 6 (b) AUTHORIZATION OF APPROPRIATIONS.—There is
- 7 authorized to be appropriated to carry out this section,
- 8 \$100,000,000 for each of fiscal years 2010 through 2014.

9 SEC. 3. PUBLIC AWARENESS AND EDUCATION CAMPAIGN.

- 10 (a) National Campaign.—The Secretary shall carry
- 11 out a national campaign to increase the awareness and
- 12 knowledge of Americans with respect to the need for pros-
- 13 tate cancer screening and for improved detection tech-
- 14 nologies.
- 15 (b) Requirements.—The national campaign con-
- 16 ducted under subsection (a) shall include—
- 17 (1) roles for the Health Resources Services Ad-
- ministration, the Office on Minority Health of the
- 19 Department of Health and Human Services, the
- 20 Centers for Disease Control and Prevention, and the
- 21 Office of Minority Health of the Centers for Disease
- 22 Control and Prevention; and
- 23 (2) the development and distribution of written
- 24 educational materials, and the development and
- 25 placing of public service announcements, that are in-

- tended to encourage men to seek prostate cancer
- 2 screening and to create awareness of the need for
- 3 improved imaging technologies for prostate cancer
- 4 detection and minimally invasive treatment.
- 5 (c) RACIAL DISPARITIES.—In developing the national
- 6 campaign under subsection (a), the Secretary shall recog-
- 7 nize and address the racial disparities in the incidences
- 8 of prostate cancer and mortality rates with respect to such
- 9 disease.
- 10 (d) Grants.—The Secretary shall establish a pro-
- 11 gram to award grants to nonprofit private entities to en-
- 12 able such entities to test alternative outreach and edu-
- 13 cation strategies to increase the awareness and knowledge
- 14 of Americans with respect to the need for prostate cancer
- 15 screening and improved imaging technologies.
- 16 (e) AUTHORIZATION OF APPROPRIATIONS.—There is
- 17 authorized to be appropriated to carry out this section,
- 18 \$10,000,000 for each of fiscal years 2010 through 2014.
- 19 SEC. 4. IMPROVING PROSTATE CANCER SCREENING BLOOD
- 20 TESTS.
- 21 (a) In General.—The Secretary, in coordination
- 22 with the Secretary of Defense, shall carry out research to
- 23 develop an improved prostate cancer screening blood test
- 24 using in-vitro detection.

1	(b) AUTHORIZATION OF APPROPRIATIONS.—There is
2	authorized to be appropriated to carry out this section
3	\$20,000,000 for each of fiscal years 2010 through 2014
4	SEC. 5. REPORTING AND COMPLIANCE.
5	(a) REPORT AND STRATEGY.—Not later than 6
6	months after the date of enactment of this Act, the Sec
7	retary shall submit to Congress a report that details the
8	strategy of the Secretary for implementing the require
9	ments of this Act and the status of such efforts.
10	(b) Full Compliance.—Not later than 1 year after
11	the date of enactment of this Act, and annually thereafter
12	the Secretary shall submit to Congress a report that—
13	(1) contains assurances that the provisions of
14	this Act are fully implemented; and
15	(2) certifies such compliance, or in the case of
16	a Federal agency that has not complied, an expla-
17	nation as to such failure to comply.
